|| Getty Images Reportage Grant: COVID-19 Impact

For over 15 years, the Getty Images editorial grants program has supported independent photographers in telling in-depth stories of personal and journalistic importance. This year, Getty Images offers eight awards of \$5,000 each to photographers reporting stories related to the COVID-19 pandemic. Beyond the public health emergency, it is a story of economic and social dislocation, and potentially one of scientific and technological innovation.

|| Emergency Response Grant Program: COVID-19

Emergency Response Program will provide funding to organizations working on projects that utilize the Internet to improve lives during or in response to an emergency situation. In 2020, the Foundation's focus will be on projects that respond to the COVID-19 pandemic, both during the immediate period of the

crisis but also looking ahead at responses to the inevitable “second wave” later this year/into 2021. Grants of \$250,000 to \$500,000 USD will be awarded for projects lasting up to 12 months.

|| Emerging Photographer Grant

What ideas do you want to convey around the themes of conservation, biodiversity, and sustainability of the natural world? Young photographers (aged 18–25) with fresh approaches to this topic are to present their perspectives in photographs and media! Two \$2,500 grants and mentorships awarded in July 2020. Works produced under the grants may be displayed at the Academy in the 2021 BigPicture Natural World Photography Exhibit.

|| Filmmakers Without Borders Grant

FILMMAKERS WITHOUT BORDERS supports independent filmmakers around the world via grants and other funding initiatives. Supported projects include narrative films, documentary films, and new media projects that align with themes of social justice, empowerment, and cultural exchange.

All applicants complete an online application and submit a variety of supporting materials including a video essay. The video essay is an opportunity for applicants to introduce themselves, describe the project, and explain how it will be successfully completed.

Grants are available in the following amounts:

- Development: \$250, \$500, \$750, or \$1000
- Production: \$500, \$1000, \$2500, or \$5000
- Post-production: \$250, \$500, \$1000, or \$2500
- Film Festival Applications: \$100, \$250, \$500, or \$750

|| Investigation Support Scheme

IJ4EU supports cross-border investigative journalism in Europe. This Investigation Support scheme provides financial support to new investigative projects, including projects that have only recently begun or new phases of existing projects. Teams can apply for between €5,000 and €50,000. The Investigation Support scheme expects to provide €800,000 in grants in 2020.

Investigation Support grants are open to teams of journalists and/or news organisations based in at least two EU member states or at least one EU member state and one EU candidate country. Proposed projects must focus on a public interest topic of cross-border relevance and aim to reveal new information.

Youth4Regions is a program to help journalism students and young journalists discover what the EU is doing in their region. As of today, they can apply to participate in the eponymous competition, and based on their application, 33 winners will be

selected. They will be invited to Brussels during the EU Week for Regions and Cities expected to take place in October 2020, where they will be able to follow trainings, receive mentorship from established journalists, work together with the latter in the pressroom and visit the EU institutions and media organizations.
