AIM OF THE CONFERENCE: Media literacy is becoming an ever-increasing topic among policymakers in European Union and its Neighbourhood region. Increased attention towards media literacy and resilience against disinformation became particularly topical in 2014, after Russian aggression towards Ukraine, and became even more acute when the world was combating the COVID-19 pandemic. Enhancement of people resilience and ability to recognise disinformation has become a joint effort by governments, international donor community and various civil society and international organisations. However, these efforts usually are sporadic and not coordinated between the parties involved.

Baltic Centre for Media Excellence (BCME), together with Baltic to Black Sea Alliance (BBSA) and in cooperation with Media Development Foundation (Georgia), Independent Journalism Centre (Moldova) and Ukrainian Media and Communication Institute, is implementing a research project "Comprehensive approach and advancement of media literacy in the Baltics and Eastern Partnership". The project has delivered an in-depth study of the media literacy sector in Latvia, Georgia, Moldova and Ukraine. In addition, it provides policy recommendations to advance media literacy.

The organisers will use the event to outline and discuss key findings from the four countries and bring together key policymakers, international donor community and project implementers to seek ways to advance media literacy and improve coordination among stakeholders and actors.

FORMAT: Online event (3 hrs long)

CONFERENCE PARTICIPANTS AND AUDIENCE: Heads of parliamentary committees from Latvia, Georgia, Moldova, and Ukraine responsible for advancing media literacy in respective countries. Authors of the country research reports, representatives of the international donor community, policymakers and organisations implementing media and information literacy projects.

WORKING LANGUAGES: English, Latvian and Russian with simultaneous translation.
